This request for expressions of interest follows the general procurement notice for this project that appeared in *Development Business* on February 17, 2009.

Montenegro has received a loan from the International Bank for Reconstruction and Development (IBRD) for a Land Administration and Management Project (LAMP).

The Ministry of Sustainable Development and Tourism (MSDT) and Real Estate Administration Department (READ) intends to apply part of the proceeds of this loan towards payment for consulting services under a contract **MNE-LAMP-7647-IC-CS-12-C.5.1** for **Information Technology Specialist** for LAMP Project Coordination Unit (PCU).

The PCU IT Specialist will be part of the Project Coordination Unit (PCU) and will report to the PCU Manager. The IT Specialist will be responsible for the overall coordination of all IT related project activities in order to ensure that the related Project objectives are achieved, within the time schedule and within the financial plan.

The IT specialist will support the MSDT and the municipalities to manage the implementation of all IT related activities and will provide guidance and support to the READ, as requested.

MSDT and READ, through LAMP PCU and Technical Service Unit now invites eligible individual consultants to indicate their interest in providing the services. Interested consultants must provide information indicating that they are qualified to perform the services (CV, brochures, description of similar assignments performed, experience in similar conditions, etc.). Individual consultants may be offered through firms or other organizations, but the qualifications of the individual consultant will be the basis of selection.

Criteria for selection of the consultant will be:

Mandatory:

- University degree in IT or related field;
- 10 years of working experience;
- 5 years of experience in managing IT projects;
- Project management certificate (PMI, PRINCE2 or equivalent);
- Good communication skills with fluency in English.

Preferred:

- Working experience on the World Bank or other international projects;
- Experience in Spatial planning GIS equivalent or similar to Montenegro.

Services are required on a full time basis (eight hours per day) for a period of one year, but can be extended until the project closing date (April, 2014).

A consultant will be selected in accordance with the selection of Individual Consultants-IC procedures set out in the World Bank's [\*Guidelines: Selection and Employment of Consultants by World Bank Borrowers\*](#) (May 2004, revised in October 2006).
