This request for expressions of interest follows the general procurement notice for this project that appeared in *Development Business* on February 17, 2009.

Montenegro has received a loan from the International Bank for Reconstruction and Development (IBRD) for a Land Administration and Management Project (LAMP).

The Ministry of Sustainable Development and Tourism (MSDT) and Real Estate Administration Department (READ) intends to apply part of the proceeds of this loan towards payment for consulting services under a contract **MNE-LAMP-7647-IC-CS-13-C.4** for **Technical Coordinator/Planning Specialist** for LAMP Project Coordination Unit (PCU).

The Technical Coordinator/Planning Specialist main activities will be coordination and assistance the municipalities in all sub-components (1. Improving the planning process and support to the Ministry of Sustainable Development and Tourism; 2. Improving the planning process at municipal level and completion of plans; 3.Improving construction permitting and inspection; and 4. Support to the business environment) and activities of the project.

The Technical Coordinator/Planning Specialist will also assist the Urban Planning Secretariats and Control Sections in the municipalities with project activities. He/she will also back-up the Technical Coordinator/PCU manager in support to MSDT in implementation of the project.

MSDT and READ, through LAMP PCU and Technical Service Unit now invites eligible individual consultants to indicate their interest in providing the services. Interested consultants must provide information indicating that they are qualified to perform the services (CV, brochures, description of similar assignments performed, experience in similar conditions, etc.). Individual consultants may be offered through firms or other organizations, but the qualifications of the individual consultant will be the basis of selection.

Criteria for selection of the consultant will be:

- An advance degree in urban and regional planning;
- At least 5 years demonstrated experience in urban and spatial planning;
- Excellent communication skills;
- Fluent in English, both written and oral;
- Experience with World Bank or other international projects preferred.

Services are required on a full time basis (eight hours per day) for a period until the project closing date (April, 2014).

A consultant will be selected in accordance with the selection of Individual Consultants-IC procedures set out in the World Bank's [Guidelines: Selection and Employment of Consultants by World Bank Borrowers](#) (May 2004, revised in October 2006).
