Montenegro has received a loan from the International Bank for Reconstruction and Development (IBRD) in the amount of EUR 11 million equivalents toward the cost of the Land Administration and Management Project and 11 mil. EUR from Government of Montenegro and intends to apply the part of the proceeds of this loan to payments for consulting services for Establishment of the Registry of planning documents and the Registry of technical documentation.

- 2. The Real Estate Administration now invites sealed bids from eligible bidders for Procurement of office furniture for the new Real Estate Administration (READ) building (office desks, conference tables, mobile pedestals, office cupboard, chairs, meeting side tables, etc).
